"Reframe" serves 50+ students grades 9th-college freshmen with college and career readiness, life and job skills, post-secondary planning, leadership, and summer internships. Results: 100% graduation rate, who either obtain jobs or college acceptance. "SMART" (Science Meets Art) serves 140+ students with experiential learning electives in music, cooking, science, technology, engineering, arts, math and more. Results: Awarded the 2018 national Innovative Education Award by Chick-fil-A.
